OFFICIAL MINUTES OF THE CITY COUNCIL REGULAR MEETING THURSDAY, SEPTEMBER 20, 2018

BE IT REMEMBERED that on the 20th day of September, A.D., 2018, the City Council held a regular meeting at 6:30 p.m. in the City Council Chambers at City Hall, 5803 Thunderbird, Lago Vista, Texas, there being present and acting the following:

Mayor Tidwell called the regular meeting to order and recognized that all Council Members were present. Mayor Tidwell led the Pledge of Allegiance.

CITIZEN COMMENTS: In accordance with the Open Meetings Act, Council is prohibited from acting or discussing (other than factual responses to specific questions) any items not on the agenda.

Linda Bush Warren, 218 Flightline Rd, made comments regarding the City asking Airport Advisory Board members to recuse themselves from discussion on the funding agreement.

ITEMS OF COMMUNITY INTEREST: Pursuant to Texas Government Code Section 551.0415, the City Council may report on any of the following items:

 - Mayor Tidwell announced a ground-breaking ceremony for ESD1 at 10 a.m. and 11:00 a.m.
 - November 3&4 they City will be doing a community collections event on Coyote Trail area using the grant money from a CAPCOG.
 - Chamber golf tournament will be held on October 5, 2018.
- f. Health and safety announcements. Lake level is up.

ACTION ITEMS (action and/or a vote may be taken on the following agenda items):

 A. Consider approval of Ordinance No. 18-09-20-01, An Ordinance of the City of Lago Vista, Texas adopting a Budget for the Fiscal Year beginning October 1, 2018, and cending September 30, 2019; appropriating the various amounts thereof, and repealing all Ordinances or parts of Ordinances in conflict therewith; and providing for an effective date.

Joshua Ray, City Manager stated that the change that was requested by Council regarding the revenue line item on the golf course, has been changed in the budget.

Joshua Ray also addressed questions from Council regarding the construction fund, CIP, golf course irrigation, unfunded items, police department budget, pipe replacement plan AMI replacement and sign replacement.

Josh Ray recommends changing the CIP budget to include in FY20, he will add \$1 million to water line replacements, \$1 million to wastewater line replacement; in FY21; remove irrigation in the amount of \$2 million; in FY21, change the funding source for the impact fee study to use impact fees and adding the description to the overall CIP plan to say that these are unfunded items until the actual annual budget is approved. Mayor Pro Tem Bland asked that another line item be added in FY21/22 for additional park grants.

On a motion by Councilman Williams, seconded by Councilman Davila, the Council voted unanimously to approve Ordinance No. 18-09-20-01with changes to the CIP as discussed.

B. Consider ratification of the portion of the FY 2018/19 budget reflecting an increase in property tax revenues.

On a motion by Mayor Pro Tem Bland, seconded by Councilman Williams, the Council voted unanimously to ratify the Municipal budget for FY 2018-2019 which raises more revenue from property taxes than in the previous year.

2. Consider approval of Ordinance No. 18-09-20-02, An Ordinance of the City of Lago Vista, Texas levying Ad Valorem Taxes for use and support of the Municipal Government of the City for the Fiscal Year beginning October 1, 2018 and terminating September 30, 2019; providing for apportioning each levy for specific purposes; and providing when taxes shall become due and when same shall become delinquent if not paid.

On a motion by Councilman Weatherly, seconded by Councilman Davila, the Council voted unanimously that the property tax rate be increased by the adoption of a tax rate of \$.65 per \$100.00 of assessed valuation, which is effectively a 1.5 percent increase in the tax rate.

3. Discussion and consideration of Ordinance No. 18-09-20-03; An Ordinance of the City Council of the City of Lago Vista, Texas pursuant to Vernon's Texas Codes Annotated, Local Government Code, Chapter 102, Section 102.007(b) providing for amendments to Ordinance No. 17-09-21-01, for the Fiscal Year beginning October 1, 2017 and ending September 30, 2018; amendments to said Budget by Department are set forth in "Exhibit A" attached to this ordinance.

Joshua Ray, City Manager addressed questions from Council regarding the water extensions and the SCADA improvements.

On a motion by Councilman Weatherly, seconded by Councilman Sullivan, the Council voted unanimously to approve Ordinance No. 18-09-20-03 as presented.

4. Discussion and consideration of Resolution No. 18-1769; A Resolution of the City Council of the City of Lago Vista, Texas, authorizing creation of an Employee Benefits Trust; designating all members of the City Council to be Trustees of said trust; authorizing the trust to purchase various forms of insurance for the benefit of city officers, employees, qualified retirees, and their dependents; and approving a transfer of assets to the trust.

Joshua Ray, City Manager provided an overview of the proposed Resolution. Starr and Josh addressed questions from Council.

On a motion by Councilman Williams, seconded by Councilman Sullivan, the Council voted unanimously to approve Resolution No. 18-1769 as presented.

5. Discussion and consideration of Ordinance No. 18-09-20-04; An Ordinance of the City Council of the City of Lago Vista, Texas, amending Chapter 1, General Provisions, of the Lago Vista Code of Ordinances, to provide for City Council Rules of Procedure and to apply the Rules of Procedure for Commissions, Boards and Advisory Committees; providing for severability; providing for a repealer; providing for publication; and providing an effective date.

The Council was provided an updated proposed Ordinance as amended by the City Attorney. She suggested adding a paragraph in Section 3.6 after "Motion to remove from table" to add a date certain.

Article 7.1, remove "All standing" at the beginning of the paragraph.

On a motion by Councilman Davila, seconded by Councilman Williams, the Council voted unanimously to approve Ordinance No. 18-09-20-04 with the discussed amendments.

6. Discussion and consideration of Ordinance No. 18-09-20-05; An Ordinance of the City Council of the City of Lago Vista, Texas, amending Chapter 1, General Provisions, of the Lago Vista Code of Ordinances, to provide for procedures to implement City Charter Provision Section 3.21, Investigations, providing for penalties; providing for publication; severability and providing an effective date.

Joshua Ray provided a brief overview of the proposed amendment and addressed questions from Council.

On a motion by Councilman Davila, seconded by Councilman Sullivan, the Council voted unanimously to approve Ordinance No. 18-09-20-05 as presented.

 Discussion and possible action regarding recommendation of contract award for the construction of the Civic Loop Waterline Project.

Joshua Ray provided a brief overview of the bids that were received for the project. Josh and Eric addressed questions from Council.

On a motion by Mayor Pro Tem Bland, seconded by Councilman Weatherly, the Council voted unanimously to award the contract for the Civic Loop Waterline project per the recommendations of the City Engineer.
