

## ORDINANCES PASSED SINCE LAST SUPPLEMENT (AUGUST 6, 2009)

**Ordinance 09-09-03-01** Amending Ordinance 09-06-04-02 by adding fees for mobile food vendor inspections and maps; providing a severability clause; providing a conflict clause, and providing an effective date.

**Ordinance 09-09-17-01** pursuant to Vernon's Texas Codes Annotated, Local Government Code, Chapter 102.007(b) providing for amendments to Ordinance No. 08-09-18-02 and any subsequent ordinances for the fiscal year beginning October 1, 2008 and ending September 30, 2009.

**Ordinance 09-09-17-02** adopting the City budget by department for the Fiscal Year beginning October 1, 2009 and ending September 30, 2010, and take any necessary action.

**Ordinance 09-09-17-03** levying ad valorem taxes in the amount of \$0.57 per \$100 valuation for use and support of the municipal government of the city for the fiscal year beginning October 1, 2009 and ending September 30, 2010; providing for apportioning each levy for specific purposes; and providing when taxes shall become due and when same shall become delinquent if not paid, and take any necessary action.

**Ordinance 09-09-17-04** allowing parking along the eastern side of Bar K Ranch Road from its intersection with FM 1431 to its intersection with Chestnut Cove for the current 2009-2010 school year; fixing a penalty therefore; declaring what may be a sufficient complaint in prosecutions hereunder; with a savings clause repealing conflicting laws.

**Ordinance 09-09-17-05** providing for a Time Limit Parking Area along the south side of the east bound portion of Dawn Drive from its intersection with Deer Run to its intersection with Travis Drive, between the hours of 7:15 A.M. to 8:15 A.M. and 2:15 P.M. to 4:00 P.M. on days when the elementary school is in session for the 2009-2010 school year; fixing a penalty therefore; declaring what may be a sufficient complaint in prosecutions hereunder; with a savings clause repealing conflicting laws.

**Ordinance 09-09-17-06** replacing paragraph 6.35 of Exhibit A, Chapter 14, Zoning, Code of Ordinances with new paragraph 6.35; establishing rules and regulations governing livestock; providing a severability clause; a conflict clause; and providing an effective date.

**Ordinance 09-10-15-01** amending Chapter 12, Traffic and Vehicles, of the City of Lago Vista Code of Ordinances by adding a new Article 12.1900, entitled "Use of Hand-Held Mobile Telephones in School Zones"; prohibiting the use of a hand-held communication device to engage in a telephone call or to send, read, and/or write a text message while operating a moving motor vehicle in an active reduced speed school zone where prohibited by sign; directing the City Manager to erect signs same in affected area; providing for a penalty of up to \$200.00 per violation; providing a repealing clause; providing a savings and severability clause; providing an effective date; and providing for proper notice and meeting.

**Ordinance 09-10-15-02** pursuant to Vernon's Texas Codes Annotated, Local Government Code, Chapter 102.007(b) providing for amendments to Ordinance No. 08-09-18-02 and any subsequent ordinances for the fiscal year beginning October 1, 2008 and ending September 30, 2009.

**Ordinance 09-11-05-01** amending Chapter 3, Building Regulations, by replacing Article 3.100, Building Code, Code of Ordinances with a new Article 3.100, Building Code; deleting Article 9.100, Chapter 9, Personnel; providing a savings clause, a severability clause and an effective date.

**Ordinance 09-11-05-02** annexing an 874.29 acre tract, more or less, as well as abutting right of way of F.M. 1431, into the corporate limits of the City at the request of Hines Lake Travis Land Limited Partnership, a Texas limited partnership; approving a service plan for the annexed area; making findings of fact; providing a severability clause; and providing an effective date.

**Ordinance 09-11-05-03** amending Ordinance 09-06-04-02 and 09-09-03-01, that establish various permit fees, other fees and rates for services provided by the City of Lago Vista; providing a severability clause; and providing an effective date.

**Ordinance 09-11-19-01** approving a Conditional Use Permit, as requested by Lago Vista ISD, for access through lots 2037 and 2039, Lago Vista Civic Center Addition, to adjacent property; providing a savings clause, a severability clause and an effective date.

**Ordinance 09-11-19-02** adopting an official map for the city; providing for maintenance and filing of the official map; and providing for related matters.

**Ordinance 09-11-19-03** amending Ordinance 09-11-05-03, that establishes various permit fees, other fees and rates for services provided by the City of Lago Vista; providing a severability clause; and providing an effective date.

**Ordinance 09-12-03-01** amending the Code of Ordinances, Chapter 1 General Provisions, Article 1.500 Purchasing, that establishes purchasing regulations; providing a severability clause; and providing an effective date.

**Ordinance 09-12-17-01** amending the zoning ordinance and the official zoning map by rezoning an 874.29 acre tract of land located on FM 1431 (approximately one mile northwest of the intersection of Bison Trail and FM 1431) from the TR-1 Zoning District to the Planned Development District; making findings of fact; and providing for related matters.

**Ordinance 09-12-17-02** providing for amendments to Ordinance No. 09-09-17-02 amending the Capital Improvement Fund budget for the fiscal year beginning October 1, 2009 and ending September 30, 2010.

**Ordinance No. 10-01-21-01** amending Article 9.1700, Impact Fee Advisory Committee, Chapter 9, Code of Ordinances concerning Committee membership; and establishing an effective date.

**Ordinance No. 10-02-04-01** amending Ordinance 09-11-19-03 by adding fees for special district applications and city drawn lot consolidation plats, amending fees for development agreement application and amending plats; adopting a new fee schedule; providing a severability clause; providing a conflict clause, and providing an effective date.

**Ordinance No. 10-02-18-01** approving a conditional use permit with additional restrictions for a boat dock at 2700 Truman Cove; providing a savings clause, a severability clause and an effective date.

**Ordinance No. 10-04-01-01** pursuant to Vernon's Texas Codes annotated, Local Government Code, Chapter 102, Section 102.007(b) providing for amendments to Ordinance No. 09-09-17-02 for the fiscal year beginning October 1, 2009 and ending September 30, 2010; amending the 2009-2010 budget to provide for appropriations to support the acquisition of and improvements to the Highland Lakes Golf Course.

**Ordinance 10-04-15-01** amending and replacing Ordinance 05-11-03-02, establishing a curfew for minors within the City of Lago Vista: defining terms; creating offenses for minors, parents, guardians and business establishments violating curfew regulations; providing defenses; providing for enforcement by the police department; providing for waiver by the municipal court of jurisdiction over a minor when required under the Texas Family Code; providing a penalty not to exceed five hundred dollars (\$500.00); repealing all ordinances in conflict herewith; providing for review of this ordinance within six months after the date of initial enforcement; providing a saving clause; providing a severability clause; and providing an effective date.

**Ordinance 10-04-15-02** pursuant to Vernon's Texas Codes annotated, Local Government Code, Chapter 102, Section 102.007(b) providing for amendments to Ordinance No. 09-09-17-02 for the fiscal year beginning October 1, 2009 and ending September 30, 2010; amending the 2009-2010 budget to provide for two additional golf course maintenance employees effective as of April 22, 2010.

**Ordinance 10-04-15-03** pursuant to Vernon's Texas Codes annotated, Local Government Code, Chapter 102, Section 102.007(b) providing for amendments to Ordinance No. 09-09-17-02 for the fiscal year beginning October 1, 2009 and ending September 30, 2010; amending the 2009-2010 budget CIP Construction Fund to provide appropriations for the Marshall's Vista construction projects.

**Ordinance 10-05-06-01** pursuant to Vernon's Texas Codes annotated, Local Government Code, Chapter 102, Section 102.007(b) providing for amendments to Ordinance No. 09-09-17-02 for the fiscal year beginning October 1, 2009 and ending September 30, 2010; amending the 2009-2010 budget to provide for expenditures for improvements to FM 1431.

**Ordinance 10-05-06-02** authorizing the Issuance and Sale of \$402,000 City of Lago Vista, Texas, Limited Tax Note, Series 2010; Prescribing the Form of the Note; Levying an Ad Valorem Tax to Pay the Note; Awarding the Sale Thereof; and Enacting Other Provisions Relating Thereto.

**Ordinance 10-05-06-03** pursuant to Vernon's Texas Codes annotated, Local Government Code, Chapter 102, Section 102.007(b) providing for amendments to Ordinance No. 09-09-17-02 for the fiscal year beginning October 1, 2009 and ending September 30, 2010; amending the 2009-2010 budget to provide for appropriations for the new golf course.

**Ordinance 10-05-17-01** providing for an order canvassing the returns of the City of Lago Vista's May 8, 2010 General Election for the Office of Council Member Place 2, Council Member Place 4, and Council Member Place 6, all offices of which are elected on an at large basis.

**Ordinance 10-05-20-01** approving a conditional use permit for a boat dock on lots 7043 Highland Lake Estates Section 7 and 7043W Cody Avenue Subdivision; providing a savings clause, a severability clause and an effective date.

**Ordinance 10-05-20-02** amending the zoning ordinance and the official zoning map by rezoning about 110 acres of property in Lake Travis from the TR-1 zoning district to the R-1C and R1-E zoning districts; granting a conditional use permit for boat docks on the land being rezoned; and providing for related matters.

**Ordinance 10-05-20-03** declaring certain submerged lands as surplus; authorizing lease and/or conveyance to the abutting property owner for value; providing findings of fact; providing severability, effective date and open meetings clauses; and providing for related matters.

**Ordinance 10-05-20-04** pursuant to Vernon's Texas Codes annotated, Local Government Code, Chapter 102, Section 102.007(b) providing for amendments to Ordinance No. 09-09-17-02 for the fiscal year beginning October 1, 2009 and ending September 30, 2010.

**Ordinance 10-05-20-05** amending Ordinance 10-02-04-01 that establishes various permit fees, other fees and rates for services provided by the City of Lago Vista; providing a severability clause; and providing an effective date.

**Ordinance 10-06-17-01** Amending the zoning ordinance and the official zoning map by rezoning about 11 acres of property in Lake Travis from the TR-1 zoning district to the R-1C zoning district; and providing for related matters.

**Ordinance 10-06-17-02** Suspending no camping regulations for a certain period for specific locations; providing a severability clause; a conflict clause; and providing an effective date.

**Ordinance 10-06-17-03** Amending Ordinance 10-02-04-01 that establishes various permit fees, other fees and rates for services provided by the City of Lago Vista; providing a severability clause; and providing an effective date.
