Mayor Mitchell called the regular meeting to order and recognized that all Council Members were present except for Suzanne Bland. Staff present: Dave Street, Mark Cote and Meredith Kuntzsch. Rev. David Hintze, Christ our Savior Lutheran Church provided the Invocation and Mayor Mitchell led the Pledge of Allegiance.

CITIZEN COMMENTS: In accordance with the Open Meetings Act, Council is prohibited from acting or discussing (other than factual responses to specific questions) any items not on the agenda.

ACTION ITEMS (action and/or a vote may be taken on the following agenda items):

4. Discussion, consideration, action if any, regarding Ordinance No. 17-09-21-04; An Ordinance of the City Council of the City of Lago Vista, Texas, amending Appendix A, Fee Schedule, Article 1.000 General and Administrative Fees, to modify Section 1.100(d) Administrative Fees; Article 3.000, Building related fees to modify Section 3.100, Building Permit Fees and 3.300 Street Cut Permit fees; Article 4.000 Business related fees, to modify Section 4.1, Signs; Article 6.000, Utility related fees, to modify Sections 6.100, Impact and Tap fees, and 6.200, Utility rates and fees; Article 7.000, Zoning fees to add Annexation/Disannexation fees; Article 9.000 Annexation fees to remove such fees in that section; Article 10.000, Parks and Recreation fees to modify 10.200, Golf Course fees; providing a savings clause; providing a severability clause; and, providing an effective date.

Kenneth Reneau provided a brief introduction and outlined specific fees that were amended. Council and Staff discussed the golf fees and rates in depth.

On a motion by Councilman Sullivan, seconded by Mayor Pro Tem Tidwell, the Council voted four (4) ayes (Sullivan, Tidwell, Mitchell, Ttppetts) to two (2) nays (R. Smith, S. Smith) to adopt Ordinance No. 17-09-21-04 with the adjustment that the Snowbird rate should be \$275 and \$375, not \$200 and \$300.

ACTION ITEMS (action and/or a vote may be taken on the following agenda items):

1. A. Consider approval of Ordinance No. 17-09-21-01, An Ordinance of the City of Lago Vista, Texas adopting a Budget for the Fiscal Year beginning October 1, 2017, and ending September 30, 2018; appropriating the various amounts thereof, and repealing all Ordinances or parts of Ordinances in conflict therewith; and providing for an effective date.

Mayor Mitchell stated that two Public Hearings were held on the Budget, one on September 7 and one on September 14.

Councilman Sullivan had questions regarding the beginning balance in the golf fund and the utility fund. Starr addressed these questions.

Mayor Pro Tem Tidwell had a question regarding the City Secretary budget regarding funds for TML. City Secretary addressed this question and stated that the funds are actually taken from the Administration budget.

Councilman Tippetts asked for clarification of the amount being subsidized to the golf course budget in the amount \$555,130. Starr stated this was correct. He also asked if there was a way that Council could stipulate that the golf course does not go over this amount. This can be stipulated in the Ordinance language.

Councilman Sullivan suggested that Council have Public Hearings when it reaches a certain amount in the budget.

Mayor Pro Tem Tidwell asked how many other departments are allowed to go over budget without coming to Council for an amendment. Starr explained that he only went over his budget at the pro shop, it's the revenue side that is not generating enough to meet the bottom line.

Gina Williams, 20703 Deede Drive, made comments regarding the course conditions at Lago.

David Williams, 20703 Deede Drive, made comments regarding membership fees.

Enrique Lopez, 6002 Lynn Ln, made comments regarding the amount subsidized.

Starr made the suggestion that Council base the trigger on the revenue side as opposed to the expenditure side.

On a motion by Councilman Sullivan, seconded by Councilman Tippetts, the Council voted four (4) ayes (Mitchell, Tippetts, Sullivan, Tidwell to two (2) nays (R. Smith, S. Smith) to approve Ordinance No. 17-09-21-01 with the following stipulation and amendment to the City's Fiscal Year 2017-2018 Budget:

The Council will have a status meeting with regard to the golf budget in the second meeting in January, April and July of next year. Motion passed.

B. Consider ratification of the portion of the FY 2017/18 budget reflecting an increase in property tax revenues.

On a motion by Mayor Mitchell, seconded by Councilman Sullivan, the Council voted unanimously to ratify the portion of the FY 2017/18 budget reflecting that increase in the property tax revenues and there is an increase in the property tax revenues of approximately \$275,566 because the appraised value of the properties increased from \$740 million to \$782.5 million between years 16/17 and year 17/18. Motion passed.

2. Consider approval of Ordinance No. 17-09-21-02, An Ordinance of the City of Lago Vista, Texas levying Ad Valorem Taxes for use and support of the Municipal Government of the City for the Fiscal Year beginning October 1, 2017 and terminating September 30, 2018; providing for apportioning each levy for specific purposes; and providing when taxes shall become due and when same shall become delinquent if not paid.

On a motion by Councilman Sullivan, seconded by Mayor Pro Tem Tidwell, the Council voted unanimously to approve Ordinance No. 17-09-21-02 as presented.

5. Discussion, consideration, action if any, regarding Ordinance No. 17-09-21-05; An Ordinance by the City Council of the City of Lago Vista, Texas, regulating the City rights-of-way by wireless network providers; approving a design manual for the installation of network nodes and support poles; approving a pole attachment agreement; providing City procedures, time periods and fees for applications for permits; adopting a public right-of-way management ordinance and annual rental rates; providing indemnity for the City; providing repealing, savings, and open meetings act clauses; providing an effective date.

Barbara Boulware-Wells, City Attorney provided an oral overview of the proposed Ordinance and exhibits and addressed questions from Council. She used about six different templates and picked different things out of each.

On a motion by Councilman Smith, seconded by Councilman Sullivan, the Council voted unanimously to approve Ordinance No. 17-09-21-05 as presented. Motion passed.

3. Discussion, consideration, action if appropriate, regarding Ordinance No. 17-09-21-03; An Ordinance of the City Council of the City of Lago Vista, Texas pursuant to Vernon's Texas Codes Annotated, Local Government Code, Chapter 102, Section 102.007(b) providing for amendments to Ordinance No. 16-09-29-01, for the Fiscal Year beginning October 1, 2016 and ending September 30, 2017; amendments to said Budget by Department are set forth in "Exhibit A" attached to this ordinance.

The Council discussed this item briefly. No action taken at this time.

On a motion by Mayor Pro Tem Tidwell, seconded by Councilman Sullivan, the Council voted unanimously to approve the above minutes with the amendments as stated above.

Mayor Mitchell advised that Mayor Powell and City Manager, Ron Wilde, of Jonestown met with Melissa Vossmer and Mayor Mitchell with regard to old Burnet Road.

This is being revisited and Jonestown has submitted a proposal to exchange some ETJ areas.

Council discussed the areas of interest and will continue discussions with Jonestown.

8. Discussion on suggested policy regarding "Winter Averaging Months" bill disputes.

Kenneth Reneau brought this for Council discussion to propose a policy to address these issues and possibly handle administratively.
