On a motion by Councilman Weatherly, seconded by Councilman Collins, Council voted unanimously that all the bids for the modular building, currently at the Green Deer golf course be rejected.

On a motion by Councilman Weatherly, seconded by Councilman Davila, Council voted unanimously that we accept the bid for the Rolling Hills property from James Fellers for \$16,100.

On a motion by Councilman Weatherly, seconded by Councilman Collins, Council voted unanimously that we accept the bid on 20705 Deep Creek from Casey Jackson for \$3,000. On a motion by Councilman Weatherly, seconded by Councilman Davila, Council voted unanimously that we accept the bid on 20707 Deep Creek from Casey Jackson for \$3,000. On a motion by Councilman Weatherly, seconded by Councilman Davila, Council voted unanimously that all bids on the Marshall's Point property be rejected.

On a motion by Councilman Weatherly, seconded by Councilman Davila, Council voted unanimously to re-advertise the Marshall's Point property for 60 days.

On a motion by Councilman Weatherly, seconded by Councilman Davila, Council voted unanimously that a counter offer for six (6) acres of land at the end of Dawn be offered to Chris Shive and authorize the City Manager to make that offer.

The Lago Vista City Council will hold a public hearing and consider Ordinance No. 19-03-07-01, an Ordinance of the City Council of Lago Vista, Texas amending the Official Zoning Map by changing approximately 31.89 acres of land being Lots 4, 5, 6 and 7 of Marshall's Harbor subdivision, save and except the Critical Water Quality Zone and adjacent twenty foot drainage easement along the west boundary of said Lots 6 and 7, from a portion of the current Marshall's Harbor Planned Development District ("PDD") to a Planned Development District ("PDD") that modifies the uses and regulations applicable to that specific portion to accommodate the development of a "retirement village."

 On a motion by Councilman Weatherly, seconded by Councilman Robbins, Council voted unanimously to pass Ordinance No. 19-03-07-01 as presented. Motion passed.

The Lago Vista City Council will hold a public hearing and consider a conditional use permit approval pursuant to Section 17 of Chapter 14 of the Lago Vista Code of Ordinances to allow exceptions to the accessory building standards otherwise applicable at 20702 Deep Creek (Lago Vista Country Club Estates, Section 1, Lot 87).
 - Open public hearing
 The public hearing was opened at 7:33 p.m.
 - Staff presentation
 Roy Jambor provided the staff presentation and addressed questions from Council.
 Brian McLaughlin, applicant, appeared and addressed questions from Council.
 - Close public hearing
 The public hearing was closed at 7:39 p.m.
 - Council discussion and action
 On a motion by Councilman Robbins, seconded by Councilman Davila, Council voted unanimously to approve the conditional use permit for 20702 Deep Creek.

ACTION ITEMS

- 6. Discussion and possible action on a Resolution 19-1791 by the City Council of the City of Lago Vista, Texas declaring certain real property owned by the City of Lago Vista to be exempt property pursuant to Texas Local Government Code Section 272.001(b) prior to subsequently considering the conveyance of that property in accordance with applicable state laws and in a manner beneficial to the City of Lago Vista.
 - Josh Ray, City Manager advised Council that staff recommends that this item be tabled until the April 4 meeting, so the larger map can be printed, and the tracts can be marked for Council review.
 - On a motion by Councilman Robbins, seconded by Councilman Weatherly, Council voted unanimously to table this item until April 4.
- Discussion and possible action on Resolution 19-1792; A Resolution by the City Council of the City of Lago Vista, Texas cancelling the regular City Council meeting scheduled for March 21, 2019.
 - Josh Ray advised Council that there are not any pressing Council items and he will be out of town for the meeting.
 - On a motion by Councilman Davila, seconded by Councilman Weatherly, Council voted unanimously to adopt Resolution No. 19-1792 cancelling the March 21 Council meeting.
- 8. Discussion and possible action to consent to the assignment of the Concession Services Contract and License to Use City Facilities at the Lago Vista Municipal Golf Course to Bakers Bar & Grill.
 - Josh Ray provided the staff summary of this item to Council. Baker's Bar and Grill would like to fulfill the remainder of Habanero Grill's contract at the Lago Vista Municipal Golf Course. Mr. Baker was in attendance and addressed questions from Council.
 - Jackie Goodwin asked about the liquor license at the facility. Mr. Baker has already applied for his own license.
 - On a motion by Councilman Weatherly, seconded by Councilman Davila, Council voted unanimously that we accept the assignment of concession services from Habanero Gill to Baker's Bar and Grill.
- 9. Discussion regarding appointing members to vacancies on the Parks and Recreation Advisory Committee and the Golf Course Advisory Committee. Josh Ray provided a brief staff summary and Council discussed briefly. The Council Liaison's will speak with the current applicants and advise staff if additional applications are needed. This item will be brought back to Council at the April 4 meeting.
